ORDINANCE NO. 1428

AN ORDINANCE TO REPEAL AND RECREATE SECTION 198-15 OF THE CITY OF ST. FRANCIS CODE OF ORDINANCES ESTABLISHING LIMITS ON HOURS OF CONSTRUCTION, TIME AND NOISE WITHIN THE CITY OF ST. FRANCIS

WHEREAS, Chapter 198 of the City of St. Francis Code of Ordinances establishes regulations concerning building construction within the City of St. Francis; and

WHEREAS, § 198-15 of the City Code currently provides limitations on hours, time, and noise pertaining to construction within the City; and

WHEREAS, the Common Council has determined that it is in the interests of the public health, safety and welfare to amend § 198-15 in light of recent amendments to Wis. Stat. § 66.1108 that restrict municipalities from prohibiting a private person from working on job site of a construction project on a Saturday or from imposing more restrictive conditions on such work than apply on weekdays; and

WHEREAS, the Council further finds that it is in the interest of the public health, safety, and welfare to amend the provisions of § 198-15 to clarify its restrictions and to address its enforcement in light of the City's use of contracted building inspection services;

NOW, THEREFORE, the Common Council of the City of St. Francis, Wisconsin do ordain as follows:

SECTION 1. Section 198-15, "Hours of construction, time and noise limitations", of the Municipal Code of the City of St. Francis, Wisconsin, is hereby repealed and recreated to read as follows:

§ 198-15. Hours of construction; time and noise limitations.

- A. Construction project activity for any private person shall be permitted between the hours of 7:00 a.m. and 8:00 p.m. daily, Monday through Saturday. Sunday hours of construction shall be between 8:00 a.m. and 5:00 p.m. Construction activity on national holidays shall be between 9:00 a.m. and 4:00 p.m.
- B. In addition to the limitations on construction activity set forth in § 198-15(A):
 - (1) No loud, environmentally disruptive building construction noises, including but not limited to noises resulting from the operation or use of air compressors, continuously running motors, generators, air hammers, power tools, other construction equipment/machinery, or loud playing radios, are permitted where such noises may unreasonably annoy or disturb the occupants or residents of other properties.
 - (2) Where emergency conditions exist (i.e. conditions which pose a threat of injury or

death to persons or damage or destruction of property), construction activity may be permitted at any hour or day of the week. Such emergency construction activity shall be completed as rapidly as possible and, to the extent reasonably possible so as to prevent unreasonably annoying or disturbing occupants or residents of other properties.

- (3) Where, based upon location and type and method of construction activity, it reasonably appears that additional hours of construction activity will not be a nuisance to adjacent properties the Building Inspector, City Engineer, or Zoning Administrator may allow hours of construction other than as stated in section (A). Such permission shall be in writing and shall specify the additional hours of construction being allowed, the type of construction that may be performed during such hours, and the date such permission shall terminate. If granted, such permission shall be subject to modification or termination by the issuing officer or the Common Council.
- C. Enforcement. The provisions of this section shall be enforced by the Building Inspector, Zoning Administrator, or any code enforcement officer designated by the Common Council. In addition, this section may also be enforced by the Police Department.
- D. Definitions. For purposes of this section:
 - (1) "Construction project" means a project involving the erection, construction, repair, remodeling, or demolition, including any alteration, painting, decorating, or grading, of a private facility, including land, a building, or other infrastructure that is directly related to onsite work of a residential or commercial real estate development project.
 - (2) "Private person" means a person (i.e. an individual, partnership, Limited Liability Company, corporation, or other organization) other than a person who is acting as an agent, employee or contractor of a political subdivision or governmental agency.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and publication as provided by law.

AN ORDINANCE TO REPEAL SECTION 105-15(B) (5), CREATE SECTION 105-29, AND TO AMEND SECTION 105-3 OF THE CITY OF ST. FRANCIS CODE OF ORDINANCES CONCERNING THE POSITION OF ZONING ADMINISTRATOR

WHEREAS, Section 105-15(B)(5) of the City of St. Francis Code of Ordinances currently designates the Building Inspector as Zoning Administrator for the City; and

WHEREAS, upon the retirement of the City's Building Inspector, the Common Council finds that it is in the public interest for the City to have the authority to designate a Zoning Administrator separately from its designation of Building Inspector;

NOW, THEREFORE, the Common Council of the City of St. Francis, Wisconsin do ordain as follows:

SECTION 1: Chapter 105, entitled "Officers and Employees", Section 105-15, entitled "Building Inspector", Subsection B, entitled "Powers and Duties", paragraph (5), entitled "Zoning Administrator", is hereby repealed in its entirety.

<u>SECTION 2</u>: Chapter 105, entitled "Officers and Employees", Section 105-29, entitled "Zoning Administrator", is hereby created to read as follows:

- § 105-29 Zoning Administrator.
- A. The Zoning Administrator shall be appointed by the Common Council.
- B. The Zoning Administrator may be an individual employed by the City or an outside firm that the City contracts with.
- C. The Zoning Administrator shall have the powers and duties of Zoning Administrator as set forth in this Code and shall serve as an adviser to the Aesthetic Control Board, Planning Commission and Zoning Board of Appeals.

<u>SECTION 3</u>: Chapter 105, entitled "officers and Employees", Section 105-3, entitled "Appointed Officials", is hereby amended by the addition of the following provision:

Official How Appointed Term

Zoning Administrator

Council

Indefinite or by contract

SECTION 4: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance

are hereby repealed as to those terms that conflict.

SECTION 5: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and publication as provided by law.

ORDINANCE NO. 1430

AN ORDINANCE TO REPEAL AND RECREATE SECTION 367-6 OF THE CITY OF ST. FRANCIS CODE OF ORDINANCES REGULATING RUMMAGE SALES WITHIN THE CITY OF ST. FRANCIS

WHEREAS, Chapter 367 of the City of St. Francis Code of Ordinances establishes regulations concerning sales and vending within the City of St. Francis; and

WHEREAS, § 367-6 of the City Code currently provides limitations on rummage sales within the City; and

WHEREAS, the Common Council has determined that it is in the interests of the public health, safety and welfare to revise § 367-6 of the City Code to eliminate the existing permit requirements for rummage sales and the related fee and to clarify the regulations applicable to rummage sales within the City; and

NOW, THEREFORE, the Common Council of the City of St. Francis, Wisconsin do ordain as follows:

SECTION 1. Section 367-6, "Rummage sales", of the Municipal Code of the City of St. Francis, Wisconsin, is hereby repealed and recreated to read as follows:

§ 367-6. Rummage sales.

A. Definitions. As used in this section, the following terms shall have the meanings indicated:

PERSONAL PROPERTY

Property which is owned, utilized and maintained and acquired in the normal course of residential living or in maintaining a residence. It does not include merchandise which was purchased for resale or obtained on consignment.

RUMMAGE SALE

Any general sale held open to members of the public (regardless of whether any admission fee is charged) that is conducted from or on a residential premises, as defined in Chapter <u>455</u>, Zoning, of this Code, that is conducted by one or more families in a neighborhood for the purpose of disposing of personal property irrespective of whether the sale is advertised or referred to as a "rummage", "estate", "lawn, "moving", "yard", "porch", "room", "backyard", patio", "flea market" or "garage" sale.

B.[Reserved]

C. Property permitted to be sold. No person shall sell or offer property other than personal property for sale at a rummage sale.

D. Limitations.

- (1) Rummage sales shall only be conducted between 8:00 a.m. and 8:00 p.m.
- (2) No more than four rummage sales may be conducted from any one premises during any calendar year.
- (3) No rummage sale shall last longer than four (4) consecutive days.
- (4) Rummage sales shall only be conducted in the following areas on the premises: driveway, garage, basement, front or rear yard, or an interior portion of the seller's home.

E. Advertising signs.

- (1) Not more than one sign per lot shall be used to advertise a rummage sale, except that on a corner lot two signs are allowed, one facing each street.
- (2) No sign advertising a rummage sale shall exceed 12 square feet in area, and such sign shall be located not less than eight feet from the nearest lot line.
- (3) Signs may only be placed upon the property of the residence where the sale is being held or upon other residential property with permission of the owner or other person in charge of such, at the time of the sale.
- (4) No sign advertising a rummage sale shall be placed within the area of any public lands or right-of-way.
- (5) No sign placed in conjunction with a rummage sale may be displayed for more than 5 days and all such signs shall be removed within 24 hours of the end of the rummage sale.

F. Penalty. Any person who violates or fails to comply with any provision of this section shall, upon conviction thereof, be subject to a penalty as provided in § 367-9 of this chapter. Each day that a violation continues to exist shall constitute a separate offense.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and publication as provided by law.
