**RESOLUTION ADOPTING THE 2023 CITY OF ST. FRANCIS BUDGET AND TAX LEVY**

THE CITY OF ST. FRANCIS COMMON COUNCIL, MILWAUKEE COUNTY, WISCONSIN, DOES RESOLVE AS FOLLOWS:

**WHEREAS**, the City of St. Francis Common Council has developed a budget for the 2023 fiscal year which includes General Fund revenues and expenditures in the sum of \$11,569,308, and;

**WHEREAS**, the proposed budget was available for public inspection in the City Clerk/Treasurer's Office prior to its presentation for public comment at a Public Hearing held November 29, 2022, and;

**WHEREAS**, the Common Council desires to appropriate the necessary funds for the operation of the government and administration of the City of St. Francis for the year 2023, and;

**NOW, THEREFORE, BE IT RESOLVED**, the proposed 2023 City of St. Francis Budget is hereby adopted as approved by the Common Council, and;

**BE IT FURTHER RESOLVED** there is hereby levied a General Property Tax of \$6,998,424 on all the taxable property within the City of St. Francis as returned by the assessor in the year 2022, for the uses and purposes set forth in the 2023 Budget, and;

**BE IT FURTHER RESOLVED**, the City Clerk/Treasurer is hereby authorized and directed to spread this tax on the current tax roll of the City of St. Francis.
